## NOTICE OF SUSPENSION HEARING

## NOTICE OF COMMISSION'S INTENT TO SUSPEND WITH SALARY

PLEASE TAKE NOTICE on the 9<sup>th</sup> of May, 2025, at 12:00 p.m., the Commission will hold a public hearing (1) regarding the Commission's Order entered April 14, 2025, rescinding and reinstating the suspension of Respondent from the exercise of judicial office, without salary, pursuant to NRS 1.4675(2)(b), and (2) to consider the possible suspension of Respondent from the exercise of judicial office, with salary, pursuant to NRS 1.4675(4).

At this hearing, the Commission will determine whether its Suspension Order, entered April 14, 2025, is still warranted following the presidential pardon and, if not, to determine whether Respondent poses a substantial threat of serious harm to the public or to the administration of justice, based upon *United States v. Michele Fiore* (2:24-cr-155). *See* NRS 1.4675(4).

The public hearing will be conducted via Simultaneous Audiovisual Transmission ("S.A.T.") utilizing the Zoom virtual platform and will be available to the public live via YouTube. The Zoom information will be distributed to parties at a later date, and the YouTube link for public viewing will be posted on the Commission's website (<a href="https://judicial.nv.gov/">https://judicial.nv.gov/</a>) under "Public Hearing Schedules" not less than 24 hours prior to the hearing.

Pursuant to NRS 1.4675(5), the Commission provides seven (7) days' notice of its intent to suspend with salary and an opportunity to respond. You may respond in writing no later than 4:30 p.m., PST, on Tuesday, May 6, 2025, or by attending the hearing in person with or without counsel. You may also waive the hearing pursuant to NRS 1.4675(5).
